Sena Development Public Company Limited ("Company"), would like to inform you that, The Executive Committee's Meeting No. 2/2562, held on January 10, 2019, has approved for the company to investment of all ordinary shares of Tha Phra Property Company Limited ("Tha Phra Property"), and providing financial assistance to Tha Phra Property. The details of the investment and providing financial assistance are as follows:

1. Acquisition of all ordinary shares of Tha Phra Property

The Company purchases all of the ordinary shares of Tha Phra Property total 3,000,000 shares at a price of Baht 100 per share or equal to a total acquisition price for the existing ordinary shares of Baht 300,000,000 (share value price). The Company purchased 2,999,998 shares from Miss Chittida Kamolsuwan and 2 shares from other existing shareholders, who do not have any relationship with the company. The Company will acquire two plots of land for future project development, amounting an area 2 rai, 2 ngan and 11 square wah (the total area is 1,011 square wah), which is the ownership of Tha Phra Property. The company has the objective to expand the Company's property development business. The details of which are as follows:

The acquisition of ordinary shares and providing financial assistance to Tha Phra Property Company Limited described above constitutes an asset acquisition pursuant to the Notification of the Capital Market Supervisory Board No. TorChor. 20/2551 Re: Rules on Entering into Material Transactions Deemed as Acquisition or Disposal of Assets (as amended) and the Notification of the Board of Governors of the Stock Exchange of Thailand ("SET") Re: Disclosure of Information and Other Acts of Listed Companies Concerning the Acquisition and Disposition of Assets B.E. 2547 (as amended) (collectively called "the Notifications on Acquisition or Disposal of Assets"). The maximum size of this transaction is equal to 5.52%, calculated under the Total value of consideration basis according to the Company's consolidated financial statements reviewed by the certified public accountant for the period ended September 30, 2018. After aggregating with other asset acquisition transactions taking place during the previous six months, the total transaction size is equal to 13.66% (The maximum transaction size under the Total value of consideration), which is lower than 15%. Therefore,



the Company is not required to disclose information on the transaction in accordance with the Notifications on Acquisition or Disposal of Assets.
